壹、 關於國際專修部 About the International Foundation Program

- 1. 修業期限:申請者預計修業期限為5年,包括華語先修課程1年以及大學學位4年。
- 2. 華語先修生統一由國際專修部輔導學生生活、經濟、學習、學習成效追蹤及就業輔導。
- 3. 依教育部核定本校 11 系所:機械工程系、電機工程系、半導體與光電工程系、電子工程系、資訊工程系、化學工程與材料工程系、生物與食品科技系、高齡福祉服務系、餐旅管理系、行銷與流通管理系、資訊管理系,於春季與秋季班招收學生。
- 4. 華語先修課程修業期間最長以1年為原則,修讀華語課程每週至少15小時以上,1年至少需達720小時以上。
- 5. 專修部學生於華語先修期間或期滿後,應達華語文能力測驗 Test of Chinese as a Foreign Language (以下稱 TOCFL)之聽力與閱讀測驗基礎級(A2)標準(附錄一),符合語言能力標準後可接續修讀原錄取之系所。
- 6. 承上,學生於華語先修期間或期滿後,如未達 TOCFLA2 標準,即予退學,並且必須離台出境。
- 7. 專修部學生於大學二年級前應達 TOCFL B1 標準。
- 專修部學生於華語先修期間不得轉系或轉學,但於正式修讀學士班專業課程1年後,得 於製造業、營造業、農業及長期照顧等相關系所轉系或轉學。
- 專修部學生於規定修業期限內修滿畢業應修學分數且成績優異者,得依本校學則第 48 條規定准其提前畢業。
- 1. Period of study: Applicants admitted in the program are expected to complete their studies in 5 years including 1 year for mandarin pre-requisite course and 4 years for bachelor program.
- 2. Chinese language pre-students will be guided by the International Foundation Program in terms of life, economics, study, learning effectiveness tracking and employment counseling.
- 3. Approved by the Ministry of Education, the school has 8 departments: Department of Mechanical Engineering, Department of Electrical Engineering, Department of Semiconductor and Optoelectronic Engineering, Department of Electronic Engineering, Department of Information Engineering, Department of Chemical Engineering and Materials Engineering, Department of Biotechnology and Food Technology, and Department of Senior Welfare and Services.
- 4. The maximum period of Chinese language prerequisites is one year. During the period, students should take at least 15 hours of Chinese language courses per week, and at least 720 hours in one year.
- 5. Within or after the Chinese language foundation program, students must meet the Basic Level (A2) standard for listening and reading of the Test of Chinese as a Foreign Language (hereinafter

- referred to as TOCFL; Appendix 1). Upon meeting the language proficiency, the student is allowed to continue study at the original department stated during admission.
- 6. As mentioned above, students who do not meet the TOCFL A2 standard will be withdrawn and must leave Taiwan.
- 7. Students should meet the TOCFL B1 standard before the second year of university.
- 8. Change of department or school is **NOT** allowed during the Chinese language prerequisite, but after 1 year of formal study in the bachelor's program, the student may change department or school but must be related to departments in manufacturing, construction, agriculture and long-term care.
- 9. International students, who have completed the required number of credits for graduation within the prescribed period of study and have excellent grades, may be allowed to graduate early in accordance with the Article 48 of the University Regulations.

伍、 申請資格 Entry Requirements

符合以下者,始具報名資格:

- 1. 法規: 申請人須符合教育部「外國學生來臺就學辦法」(附錄二)、「香港澳門居民來臺 就學辦法」(附錄三)及「僑生回國就學及輔導辦法」(附錄四)規定。
- 2. 國籍:
 - (1) 具外國國籍且未曾具有中華民國國籍、港澳身分及僑生資格者
 - i. 申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。
 - ii. 申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政 部許可喪失中華民國國籍之日起至申請時已滿八年。
 - iii. 前二款均未曾以僑生身分在臺就學,且未於當學年度接受海外聯合招生委員會分發。
 - 註1: 具外國國籍且符合下列規定,申請時並已連續居留海外 6 年以上者,得申 請入學。
 - 註2: 依教育合作協議,由外國政府、機關或學校遊薦來臺就學之外國國民,其 自始未曾在臺設有戶籍者,經主管教育行政機關核准者,不受此規定。
 - (2) 具港澳身分及僑生資格者
 - 香港或澳門居民,具有港澳永久居留資格證件,且最近連續居留境外6
 年以上,並符合香港澳門關係條例第四條規定,未持有外國護照者。
 - ii. 港澳具外國國籍之華裔學生——具外國國籍,同時兼具香港或澳門永久居留 資格,未曾在臺設有戶籍,且最近連續居留香港、澳門或海外6年以上之 華裔學生,得依「僑生回國就學及輔導辦法」第 23-1 條申請入學。
 - 註1: 僑生—海外出生連續居留迄今,或最近連續居留海外6年以上,並取得僑居地永久或長期居留證件之華裔學生。僑生身分認定,由僑務主管機關為之;港澳生(含港澳具外國國籍之華裔學生)身分認定,由教育部為之。
 - 註2: 本項招收港澳學生與僑生,概以當年度自海外回國者為限。所稱海外,係 指大陸地區、香港及澳門以外之國家或地區;所稱境外,指臺灣地區以外 之國家或地區。
 - 註3: 有關「連續居留」係指每曆年(1月1日至12月31日)在臺灣地區停留期間不得逾120日,否則視為居留中斷。期間係以本簡章申請時間截止日為計算基準日往前回溯推算6年;有關連續居留及除外規定,僑生請參閱「僑生回國就學輔導辦法」第三條及第四條;港澳生請參閱「香港澳門居民來臺就學辦法」第三條及第四條。請於報名時檢附證明文件一併繳交,以利審核。
 - 註4: 僑生及港澳生回國就學期間,除其他法令另有規定外,不得任意變更身分。若同時符合外國學生及僑生身分資格者,請擇一身分申請入學,一旦提出申請後不得變更身分。

- 3. 學歷規定: 申請國際專修部學生,必須滿足以下條件:
 - (1) 當地華語中學、外文中學畢業或取得相當於中華民國高級中學畢業取得畢業證書。
 - (2) 經中華民國駐外機構或留臺聯合總會及其各地分會之保薦單位查證屬實。
 - (3) 具有教育部「入學大學同等學力認定標準」與我國學制相當之同等學力資格者, 須附修業證明書。
 - (4) 畢業年級相當於臺灣高級中等學校二年級(Form 5)或香港、澳門地區同級同類型學校畢業生得申請學士班,且應在規定之修業期限內增加其應修專業科目共 <u>12</u> 學分。
 - (5) 持國外或香港、澳門學歷,須符合教育部「入學大學同等學力認定標準」第九 條之相關規定(附錄五)。

Applicants who meet the following requirements are eligible to apply:

1. **Regulations**: Applicants must meet the Ministry of Education regulations for International Students Undertaking Studies in Taiwan, Hong Kong and Macao Residents Regulations for Undertaking Studies in Taiwan," and Overseas Chinese Students Regulations for Undertaking Studies and Guidance.

2. Nationality:

- (1) Applicants must hold foreign nationality and have not previously held Republic of China (Taiwan) nationality:
 - i. Applicants who simultaneously hold Republic of China nationality at the time of application should not have household registration in Taiwan.
 - ii. Applicants who previously held Republic of China nationality but no longer hold it at the time of application should have been without Republic of China nationality for at least eight years from the date of approval by the Ministry of the Interior.
 - iii. Applicants in the first two categories have never studied in Taiwan as overseas Chinese students, and have not been allocated by the Overseas Joint Recruitment Committee for the current academic year.
 - Note 1: Applicants with foreign nationality who meet the following criteria and have continuously resided overseas for six years or more at the time of application may apply for admission.
 - Note 2: According to education cooperation agreements, foreign nationals recommended by foreign governments, organizations, or schools to study in Taiwan—who have never had household registration in Taiwan—may be approved by the competent education administration authority and are exempted from this regulation.
- (2) Applicants who have Hong Kong or Macao status or qualify as overseas Chinese students:
 - i. Residents of Hong Kong or Macao, who have permanent residence qualification documents for Hong Kong and Macao, and have recently lived abroad continuously

- for more than 6 years, and comply with the provisions of Article 4 of the Hong Kong and Macao Relations Regulations, and do not hold foreign passports.
- ii. Chinese students with foreign nationalities in Hong Kong and Macao—Chinese students with foreign nationality and permanent residence status in Hong Kong or Macao, who have never had a household registration in Taiwan, and who have recently resided in Hong Kong, Macao or overseas continuously for more than 6 years, can apply for "Overseas Chinese Students" Article 23-1 of "Returning to Study in China and Counseling Measures" to apply for admission.
- Note 1: Overseas Chinese students—Chinese students who were born overseas and have been living continuously to this day, or have recently been living overseas continuously for more than 6 years, and have obtained a permanent or long-term residence permit in the place of overseas residence. The identification of overseas Chinese students shall be carried out by the Overseas Chinese Affairs Competent Authority; the identification of Hong Kong and Macao students (including Chinese students with foreign nationality in Hong Kong and Macao) shall be carried out by the Ministry of Education.
- Note 2: The recruitment of students from Hong Kong and Macao and overseas Chinese in this program is limited to those who have returned from overseas in the current year. The term "overseas" refers to countries or regions outside the mainland China, Hong Kong and Macao; the term "overseas" refers to countries or regions outside Taiwan.
- Note 3: The term "continuous residence" means that the stay in Taiwan shall not exceed 120 days in each calendar year (January 1 to December 31), otherwise the stay will be deemed to be interrupted. The period is calculated back to 6 years based on the application deadline of this brochure. For the continuous residence and exclusion regulations, overseas students please refer to Articles 3 and 4 of the "Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan"; Hong Kong and Macao students please refer to Articles 3 and 4 of "Regulations Regarding Hong Kong & Macao Students Undertaking Studies in Taiwan". Please attach supporting documents when registering to facilitate review.
- Note 4: During the period when overseas Chinese students and students from Hong Kong and Macao return to their country to study, they are not allowed to change their status at will, unless otherwise provided by other laws. If you meet the qualifications of both foreign students and overseas students, please choose one status to apply for admission. Once you apply, you cannot change your status.

3. **Diploma requirements**:

(1) Obtain a diploma from one of the educational institutes: a local Chinese language school, a foreign language high school, a diploma equivalent to a high school diploma in the Republic of China (Taiwan).

- (2) Verified by the recommendation units of the Republic of China's overseas missions or the United Association of Taiwan Overseas and its local chapters.
- (3) Applicants with qualifications equivalent to the Republic of China's educational system, as determined by the Ministry of Education's <u>Admission Standards for Universities Equivalent</u> to the Republic of China, must provide a certificate of equivalency.
- (4) High school graduates from oversea including those from Hong Kong or Macao with qualification equivalent to the second year of a Taiwanese senior high school (Form 5) may apply to the bachelor programs. Applicants should complete an additional 12 credits of required courses within the specified study period.
- (5) Applicants with foreign (including Hong Kong and Macao) qualifications must meet regulations of <u>Admission Standards for Universities Equivalent to the Republic of China</u> at Article 9 set by Ministry of Education. (Appendix 5)

- * Late applications will not be accepted. Incomplete application documents or documents with illegible writing will be deemed unqualified. Applicants are responsible for ensuring that their documents are completed and legible.

玖、 申請文件 Application Documents

- 1. 入學申請表 (於線上填寫報名)。
- 2. 護照影本。
- 3. 經我國駐外使領館、代表處、辦事處或其他經外交部授權機構(以下簡稱駐外機構)驗證, 或由原修業學校提出之外國學校高中畢業畢書及歷年成績單或同等學力證明文件及成績 單(中、英文以外之語文,應附中文或英文譯本)。
- 4. 中文或英文讀書或留學計畫書。
- 5. 經駐外機構驗證或由金融機構提出足夠在臺就學之財力證明。若文件為台灣機關行號所具,則免驗證。請提供美金 4,000 元或新臺幣 12 萬元的財力證明,或依各國臺灣經濟文化辦事處或大使館規定之最低財力證明金額為準。
- 6. 最近三個月內醫院出具之健康檢查證明書一份,收到學校的錄取信後再開始做。
- 7. 申請報名費用:一律免費。
 - 註1: 繳交由原修業學校提出之外國學校最高學歷或同等學力證明文件及成績單者,若本校對於申請文件認定有疑義時,得要求補繳經駐外機構驗證之證明文件。
 - 註2: 申請時可先掃描文件上傳,取得入學許可於辦理報到時,須繳交台灣駐外機構驗證之畢業證書、成績單,始得註冊入學。申請者所繳各項證明文件經查證如有偽造、變造、假借、冒用、不實者,未入學者取消錄取資格,已入學者開除學籍,並應負法律責任。
- 1. Admission Application Form (to be completed online).
- 2. A copy of applicant's passport.
- 3. Photocopies of the high school diplomat and transcripts for all years are required. Shall the original transcripts in a language other than Chinese or English, an additional notarized copy being translated into either Chinese or English by a Taiwan Overseas Mission must provide.
- 4. A study plan or statement of purpose in English or Chinese.
- 5. Provide sufficient financial proof verified by the embassy or consulate office abroad or issued by financial institutions to demonstrate the ability to finance your studies in Taiwan. If the documents are issued by the Taiwanese government agency or institution, they are exempt from

- verification. Please provide a financial proof of US\$ 4,000 or NTD 120,000, or the minimum financial proof amount stipulated by the Taiwan Economic and Cultural Office or embassy in your country.
- 6. Provide a health certificate issued by a hospital within the last 3 months. The preparation of health certificate should be done after receiving the Acceptance Letter from STUST.
- 7. Application Fee: No application fee is required.
 - Note 1: If submitted transcripts and proof of highest academic qualifications are from a foreign institution, and the university has some concerns regarding the authenticity of these application documents, the admission committee may request additional documents that have been authenticated by the Taiwan Representative Office or consulate abroad.
 - Note 2: Applicants, when is applying, must scan and upload required documents. Upon registration at STUST, applicants must submit diploma and transcripts authenticated by one of Taiwan embassies or overseas missions. If any submitted documents are found to be forged, altered, fraudulent, or false, accepted students who have not yet registered will be disqualified, and enrolled students will be expelled from the university and may face legal consequences.

壹拾、 其他申請注意事項 Other Information for Applicants

- 1. 應屆畢業生申請者,申請時可不須繳交畢業證書。<u>如經錄取,須於開學註冊時繳交經駐</u> 外機構驗證之學歷證件正本及歷年成績單,否則取消錄取資格。
- 2. 外國學生申請來臺就學,<u>以一次為限</u>。於完成申請就學之學校學程後,如繼續在臺就學者,其入學考試應與我國內一般學生相同。外國學生申請來臺就讀學士班以下學程,在 國內停留未滿一年,因故退學或喪失學籍,得重新申請來臺就學,並以一次為限。
- 3. 僑生經輔導回國就學後,在國內停留未滿二年,因故退學或喪失學籍者,得重新申請回 國就學,並以一次為限。
- 4. 依教育部規定,就讀國際專修部學生,需在升二年級後取得台灣 TOCFL 華語文能力測驗 B1。
- 5. 依教育部規定,境外學生(外國學生、僑港澳生)凡曾遭國內大專院校以操行、學業成績不 及格或因犯刑事案件經判刑確定致遭退學者,不得再經由本管道申請入學。違反此規定 並經查證屬實者,撤銷其所獲准入學資格。
- 6. 外國學生來臺就學後,其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回 復中華民國國籍者,喪失國際學生身分,應予退學。
- 7. 依教育部規定,境外學生(外國學生、僑港澳生)註冊時,新生應檢附已於國外投保自入境當日起六個月以上效期之醫療及傷害保險,否則本校將依教育部規定請學生強制投保短期保險。
- 8. 入學申請表之電子郵件及聯絡電話請務必填寫正確。本校將依情況所需聯絡申請者,如申請者未能於期限內回覆,視同放棄本身之權益。

- 9. 申請文件一概不退還,請自行保留備份。
- 10. 本校辦理招生入學,需依個人資料保護法規定,取得並保管申請人個人資料,在辦理招生事務之目的下,進行處理及利用。本校將善盡善良保管人之義務與責任,妥善保管學生個人資料,僅提供招生相關工作目的使用。凡報名本校入學申請,即表示同意授權本校,得將自學生報名參加本招生所取得之個人及相關成績資料,運用於本校招生事務使用,並同意本校提供其報名資料及成績予學生本人及辦理新生報到或入學資料建置。
- 1. New graduates applying for admission may not be required to submit their graduation certificates during the application process. However, if admitted, original academic credentials and transcripts from previous years certified by official representative offices of Taiwan must be submitted when registering for the semester. Failure to do so may result in the cancellation of their admission.
- 2. Foreign students applying to study in Taiwan are generally limited to one entry. After completing their intended program of study, except for applying to master's or higher degree programs as per university regulations, if they wish to continue their studies in Taiwan, they will need to take the same entrance exams as local students. Foreign students applying for bachelor's degree programs or lower and staying in Taiwan for less than one year, who withdraw or lose their student status for any reason, may reapply to study in Taiwan, but they are limited to one reapplication.
- 3. Overseas Chinese students who have returned to their home country for education and stay in the country for less than two years, who withdraw or lose their student status for any reason, may reapply to return to Taiwan for education, but they are limited to one reapplication.

第一條 南臺科技大學(以下簡稱本校)為鼓勵優秀外國學生就讀本校,特訂定本辦法。

Article 1

The STUST Scholarship Establishment Regulations for International Students (hereinafter referred to as "the STUST SERIS") are established to encourage outstanding international students to study at Southern Taiwan University of Science and Technology (STUST).

第二條 本辦法所稱之外國學生係指符合教育部「外國學生來臺就學辦法」規範之外國學 生。

Article 2

The STUST SERIS are formulated based on the Ministry of Education's Regulations Regarding International Students Undertaking Studies in Taiwan.

第三條 本校設置外國學生獎學金審查小組,研訂及審查本獎學金支領標準、名額及其他相關事宜。小組成員由督導副校長、教務長、學務長、國際事務長、各學院院長組成之。 小組由督導副校長擔任召 集人,國際事務長擔任執行秘書。

Article 3

The Scholarship Review Committee is set up to initiate and review the criteria for awarding this scholarship, finalize the number of recipients, and deal with other relevant issues. Members consists of supervising Vice President, Dean of Academic Affairs, Dean of Student Affairs, Dean of International Affairs, and Deans from all the colleges. Supervising Vice President serves as the Chairperson, and Dean of International Affairs as the Executive Secretary.

- (一) 學雜費全免獎學金。
- (二) 學雜費半免獎學金。

二、碩士班:

- (一) 學雜費全免獎學金。

- (二) 學雜費全免、住宿費全免。

Article 4

Types of Scholarship for different programs of study

- 1. Undergraduate:
 - (1) Full tuition waiver.

- (2) Half tuition waiver.
- 2. Master:
 - (1) Full tuition waiver.
 - (2) Half tuition waiver.
- 3. Ph.D.:
 - (1) Full tuition waiver, a full grant for on-campus housing, and a stipend of 10,000 TWD per month.
 - (2) Full tuition waiver and a full grant for on-campus housing.
 - (3) If you go abroad for some reason during the semester with a duration of more than 16 days (inclusive), your monthly scholarship of NT\$10,000 will be suspended. Those who go abroad on official leave or business trips are not restricted.

第五條 申請者應於線上入學申請系統提出申請,流程說明如下:

- 一、上傳下列申請文件:
 - (一) 學歷證書及歷年成績單
 - (二) 二封推薦信

 - (六) 馬來西亞學生須檢附統一考試成績(UEC)、SPM 或 STPM

Article 5

Applicants should apply through the Online Application and Status Inquiry System. The procedures are as follows:

 - (1) Photocopies of original graduation diploma and official transcript.

 - (3) Study plan or research proposal.
 - (4) Autobiography.
 - (5) Certificate of Language Proficiency: English-taught programs require an English-language certificate such as TOEFL iBT score of 63 or above, IELTS score of 5.0 or above, or TOEIC score of 650 or above) or a certificate from the previous institution stating that the language of instruction was English; Chinese-taught programs require a Chinese proficiency certificate, equivalent to the Test of Chinese proficiency (TOCFL)(Basic Level) A2 or above is required.
 - (6) United Examination Certificate (UEC), SPM or STPM (only required for Malaysian students)
- 2. The application deadline for the spring semester is November 30, and the results will be announced on the online application system on December 25. The application deadline for the fall semester is May 15, and the results will be announced on the online application system on June 10.

Article 6

New students who receive this award are required to report to the Office of International Affairs and attend the orientation BEFORE the semester starts. If recipients fail to report or attend the orientation before the semester starts, their award for the semester will be cancelled. If recipients are not able to attend the orientation due to VISA issues, they are required to report within 2 weeks after the classes begin, or the award will be cancelled.

 - (一) 學雜費半免獎學金:
 - 1. 前一學期學業平均成績達及格標準。
 - 成績未達上述標準者,將取消受獎資格,爾後成績達上述標準,得提出申請 恢復續 領獎學金。
 - 3. 學雜費固定繳交新臺幣 24,000 元。
 - (二) 學雜費全免獎學金

Article 7

Starting from the FIFTH semester after admission, currently enrolled undergraduate students (excluding transfer students) who have received the scholarship are required to submit the transcript from the previous semester to the Office of International Affairs within 2 weeks after the classes begin for renewal verification. The review criteria for renewal are as follows:

- Undergraduate International Business and Finance Programs
 - (1) Half tuition waiver:
 - i. Students should maintain a minimum GPA 1.7 out of 4.3 (60 out of 100) in the previous semester.
 - ii. Students who fail to maintain the above academic criteria will be disqualified from receiving the scholarship. Once their academic performance meets the above

criteria in the subsequent semester, they may apply to have the scholarship reinstated.

iii. The tuition herein is fixed at 24,000 TWD per semester.

(2) Full tuition waiver:

- i. Students should maintain a minimum GPA 3.2 out of 4.3 (78 out of 100), or, if their GPA in the previous semester was at least 1.7 out of 4.3 (60 out of 100), they must have won an award representing the university in an international competition.
- ii. Students who failed to get the full tuition waiver will be considered for the half tuition waiver. When students qualify again in the subsequent semester, the full tuition waiver will be reinstated.

2. Undergraduate Chinese-taught Programs

- 1. Half tuition waiver: The tuition herein is fixed at 24,000 TWD per semester.
- 2. Full tuition waiver: Undergraduate students who are eligible for full tuition waiver must maintain a minimum GPA 3.2 out of 4.3 (78 out of 100).

Article 8

Starting from the THIRD semester after admission, currently enrolled master and Ph.D. students who have received the scholarship are required to submit transcripts from the previous semester to the Office of International Affairs within 2 weeks after the classes begin for renewal verification. The review criteria for renewal are as follows:

1. Ph.D. students must maintain a minimum GPA 3.38 out of 4.3 (80 out of 100), pass the evaluation of their supervising advisor, and select an advisor prior to the end of the first semester in the program. Entitlement to the stipend of NT\$10,000 monthly will be cancelled if recipients fail to meet the listed requirements. Students that fail to meet requirements

can apply for special considerations for other extenuating circumstances. The stipend will be reinstated if the application is approved by the President.

2. Master's students:

- (1) Half tuition waiver:
 - i. Students should maintain a minimum GPA 2.44 out of 4.3 (70 out of 100).
 - ii. Students who fail to maintain the above academic criteria will be disqualified from receiving the scholarship. Once their academic performance meets the above criteria in the subsequent semester, they may apply to have the scholarship reinstated.
 - iii. The tuition herein is fixed at 24,000 TWD per semester.
- (2) Full tuition waiver:
 - i. Students should maintain a minimum GPA 3.38 out of 4.3 (80 out of 100).
 - ii. Students who failed to get the full tuition waiver will be considered for the half tuition waiver. When students qualify again in subsequent semester, the full tuition waiver will be reinstated.

Article 9

Starting from the THIRD semester after admission, currently enrolled transferring students from other institutions who have received the scholarship are required to submit transcripts from the previous semester to the Office of International Affairs within 2 weeks after the classes begin for renewal verification. The review criteria for renewal are as follows:

- 1. Half tuition waiver: Fixed tuition of 24,000TWD.
- 2. Full tuition waiver: Undergraduate students who are eligible for full tuition waiver must maintain a minimum semester average score of 78 out of 100, or a GPA higher than or equal to 3.2 out of 4.3.
- 3. Students who apply for sophomore-level transfer will receive a scholarship for three years and junior-level transfer will receive a scholarship for two years.

第十條 領取本獎學金就讀大學部者最多獎勵入學後前四年,就讀碩士班者最多獎勵入學 後二年,就讀 博士班者最多獎勵入學後三年,若有特殊原因,得簽請校長核定後辦理,不 受上述獎勵年限 限制。獎學金名額視當年度本校獎學金預算而定。若受獎學生提前畢業, 立即停止受獎資格。

Article 10

The maximum length for a recipient to receive this scholarship after enrollment is the first four years for undergraduate students, the first two years for master's students and the first three years for Ph.D. students. If students have special reasons, their application needs to be approved by the President. The number of scholarship recipients will be based on STUST's budget for the current academic year. If the recipients graduate early, their scholarship will be terminated immediately.

第十一條:已領取「臺灣獎學金」、外國政府獎學金(如:「湄公 1000 專案計畫獎學金」、「菁英來臺留學 計畫獎學金」等)或本校其他獎學金者,不得重複領取本獎學金;若發現重複領取者,本校將 追回已領取之獎學金。

Article 11

Those recipients who have received a Taiwan Scholarship, foreign governmental scholarships (such as Mekong 1000 Project Scholarship, Elite Study in Taiwan Scholarship, etc.) or other scholarships will not be eligible to receive this award. If it is discovered that any students are receiving scholarships in addition to this award, they will have to choose one.

第十二條 受核定獎勵之學生如發生下列情事之一,立即取消其獎學金資格。

- 一、提供不實入學申請資料者,本校將追回已領取之獎學金並予退學。
- 二、未完成註冊或轉學離校者。
- 三、學期中途休、退學者。
- 四、前各學期未依規定繳清學雜費或積欠各種費用者。
- 五、被記小過(含)以上者。
- 六、違反校規、影響校譽行為者。

Article 12

The award will be terminated immediately when recipients:

- 1. Provide fake application materials, for which the recipients are demanded to return the award given and then would be expelled.
- 2. Transfer to other schools/universities or fail to complete the registration process.
- 3. Apply for suspension, withdrawal, or dismissal from STUST.
- 4. Defer tuition payment and other fees from the previous semester.
- 5. To be cited with minor demerits and above.
- 6. Damage the university reputation.

第十三條 本辦法經行政會議通過後,陳請校長核定後公布施行,修正時亦同。

These Regulations were officially approved at the STUST's Administrative Meeting and are made public by the President, any amendments will undergo the same process.
