## 4. 申請資格 Eligibility

1. **國籍:** 申請人必須遵守教育部《外國學生來臺就學辦法》的規定,詳細內容請參閱第 21 頁的 附錄一。

#### 2. 學歷:

- (1) 大學部申請者: 申請者必須滿足以下條件:
  - 在當地的華文中學、外文中學畢業,或取得相當於中華民國高級中學畢業的證書。
  - 經由中華民國駐外機構、留臺聯合總會及其各地分會的保薦單位進行查證核實。
  - 擁有與教育部「入學大學同等學力認定標準」相當的學歷資格,必須附上修業證明書。
  - 畢業年級等同於臺灣高級中等學校二年級(Form 5),或者香港、澳門地區相同類型學校的 畢業生可以申請本校學士班,但需要在規定的修業期限內增加12學分。
  - 持有國外、香港、澳門學歷的申請者,必須符合教育部「入學大學同等學力認定標準」 第九條的相關規定。
- (2) 碩士及博士班申請者: 申請者必須滿足以下條件:
  - 來自教育部認可的大學或獨立學院的畢業生(請參考教育部國際及兩岸教育司外國大學校院參考名冊專區)。
  - 申請碩士班者必須具有大學學歷。
  - 申請博士班者必須擁有碩士學位。
- (3) 國內大學的在學生申請轉學: 申請者必須在臺灣公立或已立案的私立大學完成至少2個學期以上的學士學位課程學習,並須上傳歷年成績單。申請者若只完成一個學期的學士學位課程學習,請以新生資格進行申請。如果被錄取,可以申請學分轉移。申請轉學者,依轉入年級與學期必須提供的成績單資訊為:
  - 轉入2年級上學期,至少要有2個學期以上的成績;
  - 轉入2年級下學期,至少要有3個學期以上的成績;
  - 轉入3年級上學期,至少要有4個學期以上的成績;
  - 轉入3年級下學期,至少要有5個學期以上的成績。
  - 另須上傳修業證明書(目前仍在學者請上傳本學期的在學證明代替)。
  - 依教育部規定,若在原學校就讀於國際專修部,則只能轉至本校的國際專修部科系。
- 1. Applicants must adhere to the Ministry of Education (MOE) Regulations Regarding International Students Undertaking Studies in Taiwan. Please refer to Appendix A on page 21 for details.
- 2. Education Background:
  - (1) For Bachelor's Degree Programs: Applicants must meet the following criteria:
    - Obtain a diploma from one of the following:
      - A Chinese-taught high school located outside Taiwan
      - A foreign language high school
      - A diploma equivalent to a high school diploma in the Republic of China (Taiwan)
    - Have their diplomas authenticated by either the overseas missions of the Republic of China or the Federation of Alumni Association of Taiwan Universities, Malaysia, and its local branches.
    - Applicants who do not meet the above qualifications but satisfy the eligibility criteria outlined in the 'Standards for Recognition of Equivalent Educational Level' must submit a Certification of Study.
    - Graduates from overseas 5-year high schools, including Hong Kong and Macau, who obtained a qualification equivalent to finishing the second year in senior high schools in Taiwan, may apply for undergraduate programs at STUST. However, they are required to complete an additional 12 course credits during their bachelor's degree studies. Individuals with a degree or diploma from an institution of higher education in Hong Kong, Macau, or overseas should also adhere to the regulations stipulated in Article 9 of the 'Standards for Recognition of Equivalent Educational Level' to qualify for university admission.

- (2) For Master's or Doctoral Degree Programs: Applicants must have graduated from one of the universities accredited by the Ministry of Education (MOE) listed in the Foreign Universities database or from independent colleges (please refer to the MOE International and Cross-Strait Education Division website). Master's degree applicants must hold a university degree, while doctoral degree applicants must possess a master's degree.
- (3) **Transfer Students:** Applicants must have completed at least two semesters of a bachelor's degree program at a public or officially registered private university in Taiwan and must upload their transcripts. If an applicant has only completed one semester of a bachelor's degree program, they should apply as a new student. If admitted, they can apply for credit transfer. For transfer applicants, the transcript information required depends on the grade level and semester of transfer:
  - The 1st semester of 2nd year, you must have completed 2 or more semesters already;
  - The 2<sup>nd</sup> semester of 2<sup>nd</sup> year, you must have completed 3 or more semesters already; The 1<sup>st</sup> semester of 3<sup>rd</sup> year, you must have completed 4 or more semesters already;

  - The 2<sup>nd</sup> semester of 3rd year, you must have completed 5 or more semesters already.
  - Certificate of Study (Proof of Drop-out withdrawal from previous university if studied in Taiwan) (students who are enrolled in the current semester have to provide the certificate of enrollment instead)
  - According to the regulation from the MOE, if students are currently enrolled in the International Foundation Program (IFP) at another university, they can only transfer to the IFP departments at STUST.

#### **5.** 語言能力基準 Proof of Language Proficiency

為了申請我們的課程,學生需要具備相對應的語言能力。如果你希望申請中文授課的課程,你需要具 備基本的華語聽說讀寫能力;如果你希望申請英語授課的課程,你需要具備基本的英語聽說讀寫能 力。因此,我們要求外國學生在申請入學時提供相關的語言能力證明,以便我們進行入學資格審查。

以下是建議的語言能力證明要求:

#### 申請英語授課課程的學生:

- 1. 通過國際認可的英語能力測驗,包括 TOEFL iBT 63、IELTS 5.0 或多益 650 分(含)以上或前段 學歷畢業學校開立之英語授課證明。申請商管學院經營管理博士學位學程另有要求,語言要求 是托福 iBT 80(含)或雅思 6.0(含)或多益 785 分(含)以上。在發送錄取通知之前,學生需要提交由 ETS 測驗中心寄送的官方分數。
- 2. 申請學生國家出現在外交部所提供的「官方語言及通用語言為英語之國家名單一覽表」(詳見 附件三)中,學生可以不用提供英語能力測驗。
- 3. 如果你在高中或更高級學校接受全英語授課,你可以選擇不參加語言測驗,但必須出示由學校 院長或系主任簽署的官方證書,證明官方教學語言為英語。

#### 申請中文授課課程的學生:

- 1. 需要具備相當於華語文能力測驗 (TOCFL) (基礎級) A2(含)以上之中文能力證明。
- 2. 如果你在高中或更高級學校接受全華語授課,你可以選擇不參加語言測驗,但必須出示由學校 院長或系主任簽署的官方證書,證明官方教學語言為華語。例如,馬來西亞獨立高中的畢業文 憑。

Applicants for programs taught in Chinese should demonstrate proficiency in listening, speaking, reading, and writing in Chinese. Similarly, applicants for programs taught in English should exhibit proficiency in English listening, speaking, reading, and writing. Proof of language proficiency must be submitted with the application. The suggested certificates for language proficiency are as follows:

#### Programs taught in English:

- (1) Passing an internationally recognized English proficiency test, such as TOEFL iBT with a score of 63, IELTS with a score of 5.0, or TOEIC with a score of 650 or higher, or providing proof from a previous educational institution that the official language of instruction was English. The application for the Ph.D. program in Business Administration at the School of Management has additional requirements. The language requirement is a TOEFL iBT score of 80 or above, an IELTS score of 6.0 or above, or a TOEIC score of 785 or above. Before an admission notice is issued, students are required to submit official scores sent directly by the ETS testing center.
- (2) The nations on "The List of Nations with English as the Official or Common Language" provided by the Ministry of Foreign Affairs, is detailed in Appendix 3. Students from those countries do not need to provide English Proficiency Test.

#### **Programs taught in Chinese:**

- (1) A Chinese proficiency certificate, equivalent to the Test of Chinese Language Proficiency (TOCFL) (Basic Level) A2 or above, is required.
- (2) Applicants who graduated from a school where Chinese is the medium of instruction during senior high school may opt not to take the exam but are required to present an official certificate from the awarding school, duly signed by the Dean or Head of the Department (such as the graduation diploma of Malaysian Independent High School), stating that the official teaching language is Chinese.

## 6. 申請文件 Application Documents

#### 入學申請所需文件:

- 1. 入學申請表: 請在線上填寫申請表格,無需支付申請費用。
- 2. 護照影本: 請提供護照的影本。
- 3. **學歷證明文件:** 請提供以下文件,經由我國駐外使館處驗證,或由原修業學校提供。如果原文件為中、英文以外的語言,請附上中文或英文的翻譯版本。
  - 大學部申請者:高中畢業證書和歷年成績單。
  - 碩士班申請者:大學畢業證書和歷年成績單。
  - 博士班申請者:碩士畢業證書和歷年成績單。
  - 轉學生:前一攻讀學校的修業證明和歷年成績單。

註1:如本校對於申請文件認定有疑義,可能要求提供經駐外使館處驗證的證明文件。

註2:申請時可以先掃描文件上傳,但需在註冊時提交台灣駐外使館或代表處驗證的畢業證書、成績單、語言檢定正本(如 TOEFL 及多益分數由 ETS 提供、雅思由官方考試中心提供,華語測驗由華語測驗中心提供),以完成註冊。如果發現申請文件涉及偽造、變造、假借、冒用、不實情況,未入學者將被取消錄取資格,已入學者將被開除學籍,並可能面臨法律責任。

- 4. 讀書或留學計畫書: 請提供中文或英文版本的讀書或留學計畫書。
- 5. 兩封推薦信: 請完成線上申請時提交兩封推薦信。
- 6. 履歷表: 如果您有工作經驗,請提供履歷表。
- 7. 其他相關能力證明文件: 提供任何其他相關能力或成就的證明文件。
- 8. **國籍及居留證明文件:** 如果您在申請時持有外國國籍,但曾經或目前持有中華民國國籍,並已連續居留海外超過六年,請提供相關證明文件。
- 9. **國籍變更證明文件:** 如果您在申請時持有外國國籍,但曾經持有中華民國國籍,並且已在臺灣 設有戶籍,請提供擁有失去中華民國國籍滿八年的證明文件,並由內政部許可。
- 10. **財力證明文件**: 提供經駐外使館處驗證或由金融機構提供的足夠在臺就學的財力證明文件。如果文件是由台灣機關發出,則無需驗證。不論您是否獲得政府獎學金,請您提供由銀行出示超過美金4,000 元或新臺幣120,000 元的財力證明文件,否則在申請入臺簽證時可能無法順利取得。倘若財力證明非申請者帳戶,需敘明資助者與申請者兩者之關係。
- 11. 馬來西亞學生申請學士課程: 請提供 SPM、STPM 或統一考試(UEC)成績單。
- 12. **健康檢查證明書:** 請提供最近三個月內醫院出具的健康檢查證明書,包括人類免疫缺乏病毒 (HIV)。

- 1. The application form should be completed online, and there are no application fees.
- 2. A copy of your passport is required.
- 3. Photocopies of your highest degree and transcripts for all years are needed. If the original transcripts are in a language other than Chinese or English, you must provide an additional notarized copy translated into either Chinese or English by a Taiwan Overseas Mission. Depending on your degree level, you should provide the following documents:
  - For Bachelor's program: High school diploma and transcripts for every semester.
  - For Master's program: Undergraduate diploma and transcripts for every semester.
  - For Ph.D. Program: Master's diploma and transcripts for every semester.
  - For Transfer Students: Original diploma and transcripts for every semester from the previous university.

**Note 1**: If STUST has doubts about the authenticity of the diploma or transcript for your highest degree or its equivalent after you submit it, we may request you to re-submit the authenticated documents through the Taiwan Embassy.

**Note 2**: When applying, you can initially scan and upload the documents. However, upon registration at STUST, you must submit the diploma and transcripts authenticated by a Taiwan Embassy or overseas mission. Language proficiency certificates should be issued by the following institutions: TOEFL and TOEIC scores from ETS, IELTS scores from an official testing center, and TOCFL certificates from the Ministry of Education, Taiwan. If the submitted documents are found to be forged, altered, fraudulent, or untrue, accepted students who haven't registered yet will be disqualified, and enrolled students will be expelled from the university and may face legal consequences.

- 4. A study plan or statement of purpose in English or Chinese.
- 5. Two recommendation letters (please complete online).
- 6. Resume (if applicants have work experience).
- 7. Any other relevant certificates or awards.
- 8. If you hold foreign nationality at the time of application and have had nationality in the Republic of China, you must submit documents for continuous residence overseas. (At the time of application, you must have been staying overseas for more than six years).
- 9. If you hold foreign nationality at the time of application, previously held citizenship in the Republic of China, and have a registered residence in Taiwan, you must submit proof of the loss of Republic of China citizenship for more than eight years, along with the confirmation certificate from the Ministry of the Interior.
- 10. Provide financial proof sufficient for studying in Taiwan, verified by an overseas embassy or issued by a financial institution. If the document is issued by a Taiwanese agency, verification is not required. Whether or not you receive a government scholarship, please provide a financial statement from a bank showing an amount exceeding USD 4,000 or TWD 120,000. Otherwise, you may face difficulties in obtaining a visa to enter Taiwan. If the financial proof is not from the applicant's account, the relationship between the sponsor and the applicant must be specified.
- 11. Malaysian students applying for bachelor's programs should submit SPM, STPM, or UEC transcripts.
- 12. A health certificate issued by a hospital within the last 3 months, including the test report for the human immunodeficiency virus (HIV). This should be done after receiving the Acceptance Letter from STUST.

### 7. 入學資格審查程序 Procedures of Admission Review

為了處理外國學生的招生申請,每個系所都設立了初審小組。系所審查完送至各院做複審,最後學校成立了校級審查小組,由督導副校長、教務長、國際事務長和各學院院長組成,督導副校長擔任會議召集人。

#### 外國學生招生的審查流程如下:

- 1. 申請文件由國際暨兩岸事務處彙整,並提交給相關的系所進行初審。
- 2. 各系所初審結果,連同會議紀錄一併提交給院做複審,最後國際暨兩岸事務處進行彙整,然後 提交給校級入學審查委員進行審查。
- 3. 校級入學審查委員的錄取建議名單及獲得獎學金類別結果呈核校長簽核後,提交本校招生委員會確認後,公告於本校國際學生線上申請及查詢系統。由國際暨兩岸事務處於線上系統公告通知學生錄取結果,學生回覆意願來本校就讀,本校發出入學通知書,以利申請人辦理抵台入境等相關手續。

To facilitate the review process for recruiting foreign students, each academic department forms a preliminary review team. The university, in turn, establishes a re-examination team consisting of the supervisory vice president, dean of academic affairs, dean of international affairs, and the deans of each college. The supervisory vice president serves as the meeting's convener.

#### The reviewing process for recruiting foreign students is as follows:

- 1. The application documents will be collected by the Office of International Affairs (OIA) and then forwarded to the respective departments for the initial review.
- 2. The preliminary review results from each department, along with the meeting minutes, are submitted to the college for assessment. Subsequently, the OIA consolidates the results and forwards them to the university-level admission committee.
- 3. After the admission recommendation list and the results of scholarship from the university-level admission review are approved the university President, they will be submitted to the university admission committee for confirmation and announced on the STUST International Students Online Application and Status Inquiry System. The OIA will notify students of admission results online. Students will confirm their intention to enroll at the university, and the university will issue an acceptance letter to facilitate the applicant's procedures for entry visa application to Taiwan.

The STUST Scholarship Establishment Regulations for International Students (hereinafter referred to as "the STUST SERIS") are established to encourage outstanding international students to study at Southern Taiwan University of Science and Technology (STUST).

第二條 本辦法所稱之外國學生係指符合教育部「外國學生來臺就學辦法」規範之外國學生。 Article 2

The STUST SERIS are formulated based on the Ministry of Education's Regulations Regarding International Students Undertaking Studies in Taiwan.

第三條 本校設置外國學生獎學金審查小組,研訂及審查本獎學金支領標準、名額及其他相關事宜。小組成員由督導副校長、教務長、學務長、國際事務長、各學院院長組成之。小組由督導副校長擔任召集人,國際事務處擔任執行秘書。

#### Article 3

The Scholarship Review Committee is set up to initiate and review the criteria for awarding this scholarship, finalize the number of recipients, and deal with other relevant issues. Members consists of Supervising Vice President, Dean of Academic Affairs, Dean of Student Affairs, Dean of International Affairs, and Deans from all the colleges. Supervising Vice President serves as the Chairperson, and Dean of International Affairs as the Executive Secretary.

第四條 各學制獎學金種類如下:

- 一、大學部:
  - (一) 學雜費全免獎學金。
  - (二) 學雜費半免獎學金。
- 二、碩士班:

- (一) 學雜費全免獎學金。
- (二) 學雜費半免獎學金。

#### 三、博士班:

- (一)學雜費全免、住宿費全免及提供每月獎學金新台幣10,000 元。
- (二)學雜費全免、住宿費全免。
- (三)學期間因故出國,當月超過 16 天(含)者,停發當月獎學金新台幣 10,000 元;公假或公差出國者不在此限。

#### Article 4

Types of Scholarship for different programs of study

- 1. Undergraduate:
  - (1) Full tuition fee waiver.
  - (2) Half tuition fee waiver.
- 2. Master:
  - (1) Full tuition fee waiver.
  - (2) Half tuition fee waiver.
- 3. Ph.D.:
  - (1) Full tuition waiver, a full grant for on-campus housing, and a stipend of 10,000 TWD per month.
  - (2) Full tuition waiver and a full grant for on-campus housing.
  - (3) If you go abroad for some reason during the semester with a duration of more than 16 days (inclusive), your monthly scholarship of NT\$10,000 will be suspended. Those who go abroad on official leave or business trips are not restricted.

#### 第五條 申請者應於線上入學申請系統提出申請,流程說明如下:

- 一、上傳下列申請文件:
  - (一)學歷證書及歷年成績單
  - (二)二封推薦信
  - (三)讀書計畫或研究計畫
  - (四)自傳
  - (五)語言檢定證明:全英授課學程需檢附英語成績證明(TOEFL iBT63 或 IELTS5.0 或多益 650 分(含)以上)或前段學歷畢業學校開立之英語授課證明,中文授課學程須檢附相當 於華語文能力測驗(TOCFL)(基礎級)A2(含)以上之中文能力證明。
  - (六)馬來西亞學生需檢附統一考試成績(UEC)、SPM 或STPM
- 二、春季班申請截止日為11月30日,審查結果於12月25日於線上入學申請系統公告。秋季班申請截止日為5月15日,審查結果於6月10日在線上入學申請系統公告。

#### Article 5

Applicants should apply through the Online Application and Status Inquiry System. The procedures are as follows:

- 1. Upload the following application documents:
  - (1) Photocopies of original graduation diploma and official transcript
  - (2) Two reference letters
  - (3) Study plan or research proposal
  - (4) Autobiography
  - (5) Certificate of Language Proficiency: English-taught programs require an English-language certificate (such as TOEFL iBT score of 63 or above, IELTS score of 5.0 or above, or TOEIC score of 650 or above) or a certificate from the previous institution stating that the language of instruction was English; Chinese-taught programs require a Chinese proficiency certificate, equivalent to the Test of Chinese proficiency (TOCFL)(Basic Level) A2 or above is required.
  - (6) United Examination Certificate (UEC), SPM or STPM (only required for Malaysian students)
- 2. The application deadline for the spring semester is November 30, and the results will be

published on the online application system on December 25. The application deadline for the fall semester is May 15, and the results will be published on the online application system on June 10.

第六條 獲得本校獎學金之新生,須於開學前至國際暨兩岸事務處辦理報到並參加新生訓練,始可領取本校獎學金;若未能於時間內完成報到及參加新生訓練,視同放棄受獎資格。若因簽證問題而無法參加新生訓練,須於正式上課日起兩週內完成報到,始得領取該學期之本校獎學金。

#### Article 6

New students who receive this award are required to report at the Office of International Affairs and attend the orientation BEFORE the semester starts. If recipients fail to report or attend the orientation before the semester starts, their award for the semester will be cancelled. If recipients are not able to attend the orientation due to VISA issues, they are required to report within 2 weeks after the classes begin, or the award will be cancelled.

- 第七條 獲得本辦法獎學金之大學部學生(不含轉學生),入學後第五學期起,於每學期正式上課日起二 週內,檢附前一學期成績單向國際暨兩岸事務處申請續領該學期之本校獎學金,續領審查標準 如下:
  - 一、大學部全英語授課國際商務及國際金融學士學位學程
    - (一)學雜費半免獎學金:
      - 1. 前一學期學業平均成績達及格標準。
      - 2.成績未達上述標準者,將取消受獎資格,爾後成績達上述標準,得提出申請恢復續 領獎學金。
      - 3.學雜費固定繳交新臺幣 24,000 元。
    - (二)學雜費全免獎學金
      - 1. 獎學金續領標準為前一學期學業平均成績達 GPA3.2 (百分制 78 分)以上或前一學期學業平均成績達半免生續領標準且代表學校參加國際競賽獲獎者。
      - 2.若未通過學雜費全免獎學金申請者,則依學雜費半免標準審查。爾後學期達學雜費 全免獎學金,得再續領學雜費全免獎學金。
  - 二、大學部中文授課學程
    - (一)學雜費半免獎學金:學雜費固定繳交新臺幣 24,000 元。
    - (二)學雜費全免獎學金:大學部學雜費全免獎學金學生學業平均成績需達 78 分(含)或 GPA3.2(含)以上。

#### Article 7

Starting from the FIFTH semester after admission, currently enrolled undergraduate students (excluding transfer students) who have received the scholarship are required to submit transcripts from the previous semester to the Office of International Affairs within two weeks after the classes begin for renewal verification. The review criteria for renewal are as follows:

- 1. Undergraduate International Business and Finance Programs
  - (1) Half tuition waiver:
    - i. Students should maintain a minimum GPA 1.7 out of 4.3(60 ouf of 100) in the previous semester.
    - ii. Students who fail to maintain the above academic criteria will be disqualified from receiving the scholarship. Once their academic performance meets the above criteria in the subsequent semester, they may apply to have the scholarship reinstated.
    - iii. The tuition herein is fixed at 24,000 TWD per semester.
  - (2) Full tuition waiver:
    - i. Students should maintain a minimum GPA of 3.2 (78 out of 100), or, if their GPA in the previous semester was at least 1.7 out of 4.3(60 out of 100), and they must have won an award representing the university in and international competition.
    - ii.Students who failed to get the full tuition waiver will be considered for the half tuition waiver.

      When students qualify again in the subsequent semester, the full tuition waiver will be reinstated.

- 2. Undergraduate Chinese-taught Programs
  - (1) Half tuition waiver: The tuition herein is fixed at 24,000 TWD per semester.
  - (2) Full tuition waiver: Undergraduate students who are eligible for full tuition waiver must maintain a minimum GPA 3.2 out of 4.3 (78 out of 100).
- 第八條 獲得本辦法獎學金之碩士及博士學生,入學後第二學期起,於每學期正式上課日起二週內, 檢附前一學期成績單向國際暨兩岸事務處申請續領該學期之本校獎學金,續領審查標準如下:
  - 一、博士班學生須於入學當學期結束前確認指導教授人選,學業平均成績須達 80 分(含)或 GPA 3.38(含)以上,及指導教授考核通過。未符前述條件者,每月獎學金新臺幣 10,000 元 將予以取消。若情況特殊,簽核准後不在此限。

#### 二、碩士班學生:

#### (一)學雜費半免獎學金:

- 1. 前一學期學業平均成績達及格標準。
- 2. 成績未達上述標準者,將取消受獎資格,爾後成績達上述標準,得提出申請恢復續領獎學金。
- 3. 學雜費固定繳交新臺幣 24,000 元。

#### (二)學雜費全免獎學金:

- 1. 碩士班學生學業平均成績平均分數須達 80 分(含)或 GPA 3.38 (含)以上。
- 2. 若未通過學雜費全免獎學金申請者,則依學雜費半免標準審查。爾後學期達學雜費全免獎學金標準,得再續領學雜費全免獎學金。

#### Article 8

Starting from the SECOND semester after admission, current enrolled master and Ph.D. students who have received the scholarship are required to submit transcripts from the previous semester to the Office of International Affairs within two weeks after the class begin for renewal verification. The review criteria for renewal are as follows:

- 1. Ph.D. students must select and advisor prior to the end of the first semester in the program, maintain a minimum GPA 3.38 out of 4.3 (80 out of 100), pass the evaluation of their supervising advisor. Entitlement to the stipend of NT\$10,000 monthly will be cancelled if recipients fail to meet the listed requirements. Students that fail to meet requirements can apply for special considerations for other extenuating circumstances. The stipend will be reinstated if the application is approved by the President.
- 2. Master's students:
  - (1) Half tuition waiver:
    - i. Students should maintain a minimum GPA 2.44 out of 4.3 (70 out of 100).
    - ii. Students who fail to maintain the above academic criteria will be disqualified from receiving the scholarship. Once their academic performance meets the above criteria in the subsequent semester, they may apply to have the scholarship reinstated.
    - iii. The tuition herein is fixed at 24,000 TWD per semester.
    - (2) Full tuition waiver:
      - 1. Students should maintain a minimum GPA 3.38 out of 4.3 (80 out of 100).
      - 2. Students who failed to get the full tuition waiver will be considered for the half tuition waiver. When students qualify again in subsequent semester, the full tuition waiver will be reinstated.
- 第九條 獲得本辦法獎學金之大學部轉學生,入學後第三學期起,於每學期開學第二週的星期五下午 5點前,檢附前一學期成績單向國際暨兩岸事務處申請續領,續領審查標準如下:
  - (一)學雜費半免獎學金:學雜費固定繳交新臺幣 24,000 元。
  - (二)學雜費全免獎學金大學部學雜費全免獎學金學生學業平均成績需達 78 分(含)或 GPA3.2(含)以上。
  - (三)轉入二年級者,獎學金給三年,轉入三年級者,獎學金給二年。

#### Article 9

Starting from the THIRD semester after admission, current enrolled transfer students from other institutions who have received the scholarship are required to submit transcripts from the previous semester to the Office of International Affairs before 5 pm on the Friday of the second week of each semester for renewal verification.

The review criteria for renewal are as follows:

- 1. Half tuition fee waiver: Fixed tuition fees of 24,000TWD per semester.
- 2. Full tuition waiver: Undergraduate students who are eligible for full tuition fee waiver must maintain a minimum semester average score of 78(inclusive), or a GPA 3.2(inclusive).
- 3.Students who apply for sophomore-level transfer will receive a scholarship for three years and junior-level transfer will receive a scholarship for two years.
- 第十條 領取本獎學金就讀大學部者最多獎勵入學後前四年,就讀碩士班者最多獎勵入學後二年,就讀博士班者最多獎勵入學後三年,若有特殊原因,得簽請校長核定後辦理,不受上述獎勵年限的限制。獎學金名額視當年度本校獎學金預算而定。若受獎學生提前畢業,立即停止受獎資格。

#### Article 10

The maximum length for a recipient to receive this scholarship after enrollment is the first four years for an undergraduate students, the first two years for master's students and the first three years for Ph.D. students. If students have special reasons, their application needs to be approved by the President. The number of scholarship recipients will be based on STUST's budget for the current academic year. If the recipients graduate early, their scholarship will be terminated immediately.

第十一條 已領取「臺灣獎學金」、外國政府獎學金(如:「湄公 1000 專案計畫獎學金」、「菁英來臺留學計畫獎學金」等)或由本校、外校核發之其他獎學金者,不得重複領取本獎學金;若發現重複領取者,本校將追回已領取之獎學金。

#### Article 11

Those recipients who have received a Taiwan Scholarship, foreign governmental scholarships (such as Mekong 1000 Project Scholarship, Elite Study in Taiwan Scholarship, etc.) or other scholarships issued by STUST or other universities will not be eligible to receive this award. If it is discovered that any students are receiving scholarships in addition to this award, they will have to choose one and return the award given.

第十二條 受核定獎勵之學生如發生下列情事之一,立即取消其獎助資格。

- 一、提供不確實入學申請資料者,本校將追回已領取之獎學金並予退學。
- 二、未完成註冊或轉學離校者。
- 三、學期中途休、退學者。
- 四、前各學期未依規定繳清學雜費或積欠各種費用者。
- 五、被記小過(含)以上者。
- 六、犯有影響校譽行為者。

#### Article 12

The award will be terminated immediately when recipients:

- 1. Provide fake application materials, for which the recipients are demanded to return the award given and then would be expelled.
- 2. Transfer to other schools/universities or fail to complete the registration process.
- 3. Apply for suspension, withdrawal, or dismissal from STUST.
- 4. Defer tuition payment and other fees from the previous semester.
- 5. To be cited with minor demerits and above.
- 6. Damage the university reputation.

第十三條 本辦法經行政會議通過後,陳請校長核定後公布施行,修正時亦同。

Article 13

These Regulations were officially approved at the STUST's Administrative Meeting, promulgated by the President, and implemented accordingly. Any amendments will undergo the same process.
